Antigua and Barbuda has new Prime Minister

OECS member states will soon welcome the newest Head of State to the sub-regional Organisation. Today, new Prime Minister of Antigua and Barbuda, Mr. Baldwin Spencer was sworn into office.

In an interview with GIS News, OECS Communications Officer Raymond O'Keiffe, who grew up in Antigua says the new Prime Minister will have a packed agenda to attend to at the OECS and regional level.

"If he does not attend the CARICOM Heads of Government Meeting, in St. Kitts, he will certainly be informed in terms of developments at this meeting, and in addition to that there is the OECS Heads of government meeting scheduled for May, this year in St. Vincent, and I am sure that he will be attending that meeting. He will definitely be welcomed by the OECS Heads of Government," commented Mr. O'Keiff.



Like the other Heads, Prime Minister Spencer is expected to bring his experience and competence to bear on the mandate of the OECS, Mr. O'Keiff said, adding that he is a Trade Unionist; he has had a lot of exposure; and he is a people person, who knows about the issues affecting people.

When the heads of government meet, they plan strategies and endorse programmes to facilitate the development of human resources in the sub- region, so that they can meet the expectations of globalisation.

Former Prime Minister Lester Bird had been at the helm of Antigua and Barbuda since 1994, when he took over the leadership of the twin island nation from his father, Vere Bird. The post of prime minister had been in the Bird family since the country obtained independence from Britain in 1981.

Two New Diplomats for Saint Lucia

SAINT LUCIA will soon see the introduction of two new diplomats. On Thursday, March 25th, 2004 Mr. Maarten Van der Gaag, Ambassador-designate of the kingdom of the Netherlands will present his Letters of Credence to Governor General Her Excellency Dame Pearllette Louisy in a ceremony at Government House.

Mr. Van der Gaag is presently the Ambassador Extraordinary and Plenipotentiary of Her Majesty the Queen of the Netherlands at Port of Spain, Trinidad and Tobago, and is also accredited to Antigua and Barbuda, Barbados, The Commonwealth of Dominica, Grenada, St. Christopher and Nevis and St. Vincent and the Grenadines.

While on the island, the ambassador will pay courtesy calls on the Permanent Secretary in the Ministry of External Affairs, International Trade and Civil Aviation, Mr. Cosmos Richardson; Attorney General, Honourable Petrus Compton; as well as the Leader of the Opposition, Hon. Arsene James.

On Thursday, April 1, 2004, it will be the turn of Mr. Om Prakash, High Commissioner-designate of India to present his Letters of Credence.

Mr. Prakash has served in a number of capacities including Secretary of the Embassy of India, and Deputy Director General in the Ministry of External Affairs in New Delhi.

WTO Dispute Settlement Seminar Underway Here

WORK has gotten underway here aimed at giving trade officials an improved knowledge of the dispute settlement rules, procedures and practices governing World Trade Organization (WTO) negotiations. The latest initiative comes in the form of a week long regional seminar which started Monday, March 22nd at the Bay Gardens Hotel.

The event has been organized by the WTO, the CARICOM Secretariat, the Inter-American Development Bank, and Ministry of Foreign Affairs and International Trade. Deputy Programme Manager for External Economic and Trade Relations at the CARICOM Secretariat, Valerie Alleyne-Odle says over 20 similar sessions have taken place exposing over 200 regional officials to the various WTO disciplines.

This particular seminar will hopefully prove beneficial as participants seek to implement the dispute resolution mechanisms at the level of the single market and economy. Also, it is hoped that at the end of the seminar, "the region will be better able to deal with the inevitable challenges that may arise not only at the level of the WTO, but with respect to all other trading relations like the FTAA, and many of our bilateral agreements," notes Mrs. Alleyne-Odle.

Given the very limited administrative capacity and human resources of small states, trade officials say St. Lucia and the wider CARICOM grouping will continue to press the case for greater assistance to be given to smaller economies, in order to facilitate their effective participation within the WTO dispute settlement mechanism. That view is sheared by External Trade Advisor in the Ministry of Foreign Affairs and International Trade, Calixte Leon. He emphasized that "followers of debates involving dispute settlement would recognize that the cost of participating in such settlement procedures was exorbitant," much beyond the capacity of small countries like St. Lucia.

While commending the initiative taken to promote the effective participation of all WTO members in dispute settlement proceedings, the senior government official pointed out that most small economies were still unable to afford the discounted rates being charged. St. Lucia, he says welcomes a suggestion to have a pool of WTO lawyers to assist in cases. Notwithstanding that, he says individual small economies have little capacity to either mount or defend their cases.

The odds appear to be staked even further against small states Mr. Leon laments, "in that if a small state was ever to be successful in a dispute against a larger WTO member, and the WTO member concerned fails to bring its measure into conformity with the WTO provisions, it would be very difficult for that smaller country to impose sanctions." In light of those developments Mr. Leon says CARICOM must continue to lobby at ensuring that small economies are better able to participate in the dispute settlement mechanism.

He suggested among other things, the need for WTO members to show due constraint in invoking dispute settlement procedures against small states.

NCF Receives \$25,000 in Donations

Budget Day is April 20th

PRIME Minister Dr Kenny D. Anthony has announced that Budget Day 2004 will be on Tuesday, April 20th. The announcement follows today's regular Cabinet Meeting.

On that date, Dr Anthony, in his capacity as Minister of Finance, Economic Affairs, International Financial Services and Information, will deliver his Annual Estimates of Revenue and Expenditure to the House of Assembly.

Preparations for this year's budget began rather earlier than usual, starting immediately after the official celebrations to mark the island's 25th Anniversary of Independence.

Since then, the Prime Minister, along with representatives of the Budget Section and other Finance Ministry officials, has been meeting with various Government Agencies to hear and consider their budgetary proposals for Fiscal year 2004-05.

Last year's Budget Address, which was delivered on April 8, had as its theme, "Advancing Infrastructural Development and Economic Recovery in an Uncertain World."

Preparations for this year's budget are continuing apace, with the Prime Minister attending daily meetings related to the process.

When this year's Budget Address is delivered by the Prime Minister in the House of Assembly, it will be carried live on local radio and TV stations.

The address will be preceded by the annual Throne Speech by Her Excellency the Governor General and will be followed by the Budget debate, during which Government and Opposition Members of Parliament (MPs) will make their contribution to the discussion of the proposed Estimates of Revenue and Expenditure for the next Fiscal year.
