Toyota to add solar panels to Prius hybrids

Toyota Motor Corp plans to install solar panels on some Prius hybrids in its next remodeling, responding to growing demand for "green" cars amid record-high oil prices, a source briefed on the matter said on Monday.

The panels, supplied by Kyocera Corp would be able to power part of the air-conditioning on high-end versions of the gasoline-electric Prius, the source said.

"It's more of a symbolic gesture," said the source, who asked not to be identified. "It's very difficult to power much more than that with solar energy."

Toyota is due to launch the third-generation Prius next year.

Big automakers are racing to come up with alternative solutions to using fossil fuels to appear ecologically conscious and to lure consumers looking to save money at the pump.

But solar power is not seen as a viable solution to power cars. Solar panels are expensive due to rising silicon prices and storing energy is difficult, the source said. It was unknown how much the solar panels on the new Prius cars would cost, or how

many solar-mounted versions Toyota would build.

A Toyota spokesman declined to comment, saying the company does not talk about future product plans.

Mazda Motor Corp briefly offered a solar panel option on two car models, the Eunos 800 and Sentia, in the early 1990s to ventilate the sedans while parked on hot summer days. The expensive option was unpopular and discontinued after a few years.

Kentaro Endo, a director at Japan's Ministry of Economy, Trade and Industry who specializes in renewable energy, said the application of solar energy was severely limited in vehicles.

"Even if you laid solar panels out on the entire roof of a house, you only generate enough energy to run two hair dryers," he said. "It's an interesting idea, but it would be very difficult to power a whole car, even with technological advances."

Toyota has struggled to keep up with demand for the Prius as soaring gasoline prices put consumers off of gas-guzzling sport utility vehicles and pickup trucks.

Rival Honda Motor Co will also step up its hybrid push with a new, low-cost model early next year, followed by several other gasoline-electric cars.

Automakers have teamed up with battery makers to develop and produce lithium-ion batteries to store more energy in smaller packages to extend cruising distances.

Toyota has partnered with Matsushita Electric Industrial Co while Nissan Motor Co has a joint venture with the NEC Corp group. Mitsubishi Motors Corp is working with GS Yuasa Corp.

The Prius, the world's first mass-produced gasoline-electric hybrid car, first went on sale in Japan in late 1997 and in other markets in 2000. Cumulative sales have topped 1 million units worldwide.

Toyota has a goal of selling at least 1 million hybrid cars a year in the early part of the next decade by offering the fuel-saving system on more vehicles.

Toyota shares ended 1.4 percent higher at 4,990 yen as the dollar rose against the yen. Kyocera lost 0.1 percent to 9,740 yen, while the Nikkei average gained 0.9 percent.



ECSE

Eastern Caribbean

Mild activity was recorded on the ECS with Dominica Electricity Services trading down 20 cents to close at \$2.60 while ECFH traded firm at \$15.00.

The volume leaders on the Trinidad Stock Exchange, Trinidad Cement Limited followed by Sagicor, accounted for over 60% of total stocks traded. 12 stocks advanced while 7 declined with National Enterprises Limited and Trinidad Cement limited leading the advancers, increasing

by 6.5 % and 4.88% respectively. Sagicor lead the decliners closing at TT\$20.99, down 3% from last weeks closing price.

The US President has ordered the termination of Trinidad and Tobago's access to a preferential trade programme known as the General System of Preferences effective January 1 2010 - on the grounds that Trinidad has become a "high income country" according to World Bank Statistics. An economist stated that the county's GDP per capita has grown rapidly over the past four years to reach US\$16,105.

JAMAICA:

All three indices on the JSE recorded declines for the week, with over 11 million shares changing ownership. A total of 37 stocks traded with an advance decline ratio of 17 to 14, with 6 trading firm. The volume leaders were NCB Jamaica and Scotia Group Jamaica followed by Grace Kennedy Limited with a consolidated volume of over 6 million shares.

In other news, on 30th June, 2008 the JSE created history by being the first stock exchange in the region to be listed on its own stock exchange.

BARBADOS:

On the BSE, the total volume traded on the Regular market exceeded 130000, with Fortress Caribbean Property Fund, Ansa Macal (Barbados) Limited emerging volume leaders. Neal and Massy Holdings Limited was the sole advancer while Sagicor and Banks Holdings both declined.

INTERNATIONAL:

And finally on the international front, stocks tumbled for another week on concern that rising crude oil prices and the credit crisis will slow global economic growth.

In commodities and currencies news, gold closed at \$935, while the Euro fell against the dollar as worsening economic outlook deters the Euro Central bank from increasing its discount rate.

Cricket

Dyson urges players to curb aggression

After slumping to a 5-0 series whitewash to Australia on Sunday, John Dyson, the West Indies coach, wants his players to move away from their way of playing cricket and instead adopt the style of the Australians.

Dyson emphasised that his team would get no better unless they curbed their aggression and played with a more clinical approach. "The first step is for the players to embrace the concept that we need to change some things about our game," Dyson said. "Up

until now, I don't think a lot of them have. We play the West Indies way. We bowl aggressively. We bat aggressively. We field aggressively.

"When you analyse what all that means, you start to realise that every now and then you win doing that, but against the better sides that approach it more clinically, it's not going to happen."

Dyson has enjoyed mixed results since taking over last year. The series defeat, including a massive 169-run loss in the final ODI, was among the lowest points in his tenure. In calling for his players to emulate the Australians, Dyson pointed to a few examples.

"Teams like Australia build pressure by bowling many dot balls. They make it very difficult to score," he said. "Since the South Africa tour, I've been told the West Indian way is not to do that. We are aggressive.

We try and get people out. That's fine, but you see the result of that. We have some good days and we have some shockers.

"We have to accept that we need to change our approach to various things. The potential is there. We have some very talented players with lots of potential but to compete with teams at the top of the table, there are some changes that they need to accept they need to make to their game."

However, he cautioned that things can't change overnight. "I am not a magician. I can't just click my fingers and go . . . everything's done. Take the Australian side, look at Luke Ronchi's overall cricket CV and you will find that he had played a whole lot of good quality one-day cricket before getting here. He has been learning the basic skills for a long time. Unfortunately, we are getting players that have only played a handful of games in some cases."

TENNIS

Paris to D.C.: Serena's long commute for WTT debut

Three days after losing to her sister in tennis' showcase event, Serena Williams awoke Tuesday morning at her part-time home in Paris. She flew to London, where she had a layover of a few hours, then hopped a trans-Atlantic flight in which she "slept pretty much the whole way."

Upon arrival in the nation's capital, she made an appearance at a youth tennis clinic and then held a news conference to promote the final duty of her very long day: her debut with the Washington Kastles of World Team Tennis. "It's kind of weird, but I'm still going," said Williams, whose body clock was closing in on midnight at the news conference.

Five hours later, the world's fifth-ranked player showed no signs of jet lag as she pounded aces and service winners against No. 189 Marie-Eve Pelletier. Williams won seven of 10 games against Pelletier in a valiant comeback bid on behalf of the team, but it wasn't enough as the Kastles lost their home opener 22-19 to the Boston Lobsters.

"I wasn't exhausted at all," Williams said. "I felt like I could go another two sets or whatever."

Under a crescent moon and before a standing room only crowd, Williams also played doubles and mixed doubles in her

all-white outfit. She and Justin Gimelstob, who caused a stir and drew a one-match WTT suspension when he made disparaging comments about Anna Kournikova last month, lost 5-2 to Jan-Michael Gambill and Raquel Kops-Jones. Williams then teamed with Mashona Washington to beat Pelletier and Kops-Jones 5-4 in women's doubles.

"It was good to be out here in D.C. for the first time," said Williams, who stuck around a bit longer after playing to sign autographs. "It was awesome."

The taxing day was not the usual routine for a professional athlete preparing for competition, but the WTT will take what it can get. The Kastles are the newest franchise in the 11-team league, which began its 33rd season this month, and the team's home matches are played in a temporary, 2,200-seat stadium that has been erected in the middle of a downtown parking lot. During a break in the action, WTT co-founder Billie Jean King stepped onto the court and auctioned off Super Bowl tickets.

"I always thought there should be a (women's) tennis tournament here," Williams said. "It's such a big city, and I have a lot of fans here."

The match had been long sold out—it is scheduled to be Williams' only home appearance with the Kastles this season—and the intimate atmosphere and multicolored hardcourt were literally and figuratively half a world away from the grass of Centre Court at Wimbledon, where she lost to sister Venus in the grand slam final on Saturday.

"I was really disappointed. . . I've been down already," Williams said before Tuesday's match. "I'm so excited to play.

I've never been so ready to play so fast, after such a big tournament. But I'm definitely ready and I'm looking forward to having a lot of fun out there."

Even if fatigue had set in, there was no danger of Williams falling asleep. Announcers with microphones turned up to max volume constantly reminded the crowd that loud cheering always is encouraged at WTT matches. It took a while to get the message across, but eventually there were chants of "Double fault!" while Kops-Jones was serving during mixed doubles.

Williams last played in WTT in 2000 for the Delaware Smash. She was on the St. Louis Aces roster last year but was unable to complete due to injury. Joining the Kastles comes with a family tie; one of her less famous sisters, Isha, works for the local Southeast Tennis & Learning Center.

The WTT schedule is condensed into three July weeks, with each team boasting a marquee player who will play in at least one home match. Serena Williams is scheduled to play in three of the Kastles' road matches. Other notable names in the league include Andy Roddick, Martina Navratilova, Lindsay Davenport and Anna Kournikova.

And, oh yes, Serena's sister, who plays for the Philadelphia Freedoms.

"That's the beauty of WTT. It attracts a lot of marquee players. Venus Williams, who's won five Wimbledon, I believe," said Williams, stumbling through the thought as if she were still coming to grips with the mixed emotions of losing Saturday's final.

"Obviously, I was happy for her," Williams said. "I wouldn't want her to lose any other time—unless she lost against me."
