

THE National Awards Committee invites nominations for National Awards to be announced at our Thirty Fourth (34th) Anniversary of Independence on 22nd February, 2013.

As you may be aware, the Society of Honour known as the Order of Saint Lucia was established from 13th December, 1986.

The grades are as follows:

The Grand Cross

The Saint Lucia Cross

The Medal of Honour in classes of Gold and Silver

The Medal of Merit in classes of God and Silver

The Les Pitons Medal in classes of Gold, Silver, and Bronze

The National Service Cross

The National Service Medal

GRAND CROSS:

The Grand Cross is for award only to a person appointed to the office of the Governor-General.

NATIONAL SERVICE CROSS:

Nominations for an award of the National Service Cross can only be made by the Chairman, Public Service Commission as this award is intended for Gazetted Officers of a certain rank in the Royal Saint Lucia Police Force, the Saint Lucia Fire Service and the Saint Lucia Prison Service.

NATIONAL SERVICE MEDAL:

Nominations for the National Service Medal can only be made by the officers in charge of the Royal Saint Lucia Police Force, the Saint Lucia Fire Service and the Saint Lucia Prison Service.

The general public should therefore be concerned with nominations for the following four (4) grades:

- (a) The Saint Lucia Cross;
- (b) The Medal of Honour;
- (c) The Medal of Merit; and
- (d) The Les Pitons Medal.

SAINT LUCIA CROSS:

The Saint Lucia Cross is to be awarded to persons who have rendered distinguished and outstanding service of national importance to this country.

MEDAL OF HONOUR (SLMH):

The Medal of Honour is to be awarded in any two (2) classes (Gold or Silver) to persons rendering eminent service of national importance or performing an outstanding brave or humane act to a national of Saint Lucia or of another country.

MEDAL OF MERIT (SLMM):

The Medal of Merit is to be awarded in any two (2) classes (Gold or Silver) to persons contributing long and meritorious service in the Arts, Science, Literature and other such fields.

THE LES PITONS MEDAL (SLPM):

The Les Pitons Medal is to be awarded in any of three (3) classes (Gold, Silver; or Bronze) for long and me ritorious service to Saint Lucia, tending to promote loyal public service, national welfare or inculcating and strengthening community spirit.

THE Government of Saint Lucia through the Ministry of Commerce, Business Development, Investment and Consumer Affairs is inviting tenders for the supply of Wheat Flour for the period January 2013 to December 2013. The required specifications are shown hereunder:

Characteristics: Moisture content Requirements: not more that 15%

Characteristics: Ash content: Requirements: not more that 1.2% before adding inorganic matter

Characteristics: Protein content: Requirements: 12.0 - 13.5%

Packaging Requirements:

Wheat Flour shall be packaged in containers that will safeguard the hygienic, nutritional, and Technological characters of the flour, and protect it against contamination or absorption of moisture.

Containers shall be made of materials that are safe and suitable

for the purpose, such as bags or sacks made of new cotton cloth, multi-wall paper, strong paper and new plastic film.

Containers shall not contaminate the product by migration of any toxic substance, or give the flour any undesirable odor or flavour.

Labelling Requirements:

The labeling on retail packages of flour shall be in the English Language, clearly and prominently displayed, and readily legible under customary conditions of purchase and use.

The information carried on the label shall include the following:

The name of the food, "Flour", "Wheat Flour" or "White Flour"

Any brand name or trade name

The name of the manufacturer or of the person controlling the brand name or trade name, together with an adequate postal address

The name of the country of origin

The net contents of each package when packed in terms of units of mass in grams (g) or kilograms (Kg), (which may also be shown in avoirdupois pounds and ounces) using Arabic numerals

The batch number, date of manufacture, together with expiry date or best before date of minimum durability

Handling and Storage instructions

Where an indication of the type of flour is included on the label, the protein and ash contents of the flour shall be within the limits set out in Table 3 of the compulsory standard for Wheat Flour (SLNS 10: 1992).

General purpose] **Protein Content:** 10.5 to 12.0 %

Ash Content: up to 0.5 %

Type of Flour: Biscuit

Protein Content: 8.0 to 9.0 % Ash Content: up to 0.45 %

Transportation:

Wheat Flour shall be shipped containerized in vessels suitable for transporting foodstuffs for human consumption.
