AN ACT to provide for the services of the State of Saint Lucia for the year ending on the thirty-first day of March, two thousand and twenty.

[13th May, 2019]

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the House of Assembly and the Senate of Saint Lucia, and by the authority of the same as follows:

Short title

1. This Act may be cited as the Appropriation Act, 2019/2020.

Appropriation of \$1,591,589,000 for services of the State of Saint Lucia for the year 2019/2020

2. There shall be and there is hereby granted to Her Majesty the Queen, Her Heirs and Successors for the year ending on the thirty-first day of March, two thousand and twenty, the sum of one billion, five hundred and ninety-one million, five hundred and eighty-nine thousand, dollars, to be paid and appropriated out of the General Revenue and funds of the State of Saint Lucia for the said year in such quarterly amounts as the Minister of Finance may consider appropriate and to be approved and to be expended in the manner and for the purposes mentioned in the Schedule to this Act.
