LOBSTER OPEN FISHERY 2023 - 2024

THE Department of Fisheries within the Ministry of Agriculture, Fisheries, Food Security and Rural Development informs the general public that the lobster fishery opens from **Wednesday**, **August 02**, **2023 to Wednesday**, **February 28**, **2024**, both days inclusive.

 - (a) less than 9.5 centimeters (3.75 ins.) in carapace length measured from the ridge at the base of the horns to the end of the carapace (back shell); or
 - (b) if the tail has been removed, a tail weight of less than 340 grams (12 ounces).

Contravention of these Regulations is subject to a maximum fine of **EC\$5000.00**.
