AN ACT to provide for expenditure during the financial year ending on the thirty-first day of March, two thousand and twenty-two for services of the State of Saint Lucia in excess of the Appropriation Law for the year ending on the thirty-first day of March, two thousand and twenty-two.

[21st March, 2022]

WHEREAS the sum of money granted by the Appropriation Act, No. 2 of 2021 for the services of the State of Saint Lucia for the year ending on the thirty-first day of March, two thousand and twenty-two is insufficient to meet the demands of such services.

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the House of Assembly and the Senate of Saint Lucia, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the Supplementary Appropriation Act, 2021/2022.

Supplementary appropriation of \$9, 870,400 for services of the State of Saint Lucia for the year 2021/2022

2. There shall be and there is hereby granted to Her Majesty the Queen, Her Heirs and Successors for the year ending on the thirty-first day of March, two thousand and twenty-two, Nine Million, Eight Hundred and Seventy Thousand and Four Hundred Dollars, to be paid and appropriated out of the General Revenue and funds of the State of Saint Lucia for the said year in amounts as the Minister of Finance considers appropriate and to be approved and to be expended in the manner and for the purposes mentioned in the Schedule to this Act.
