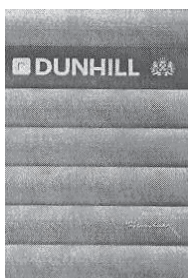

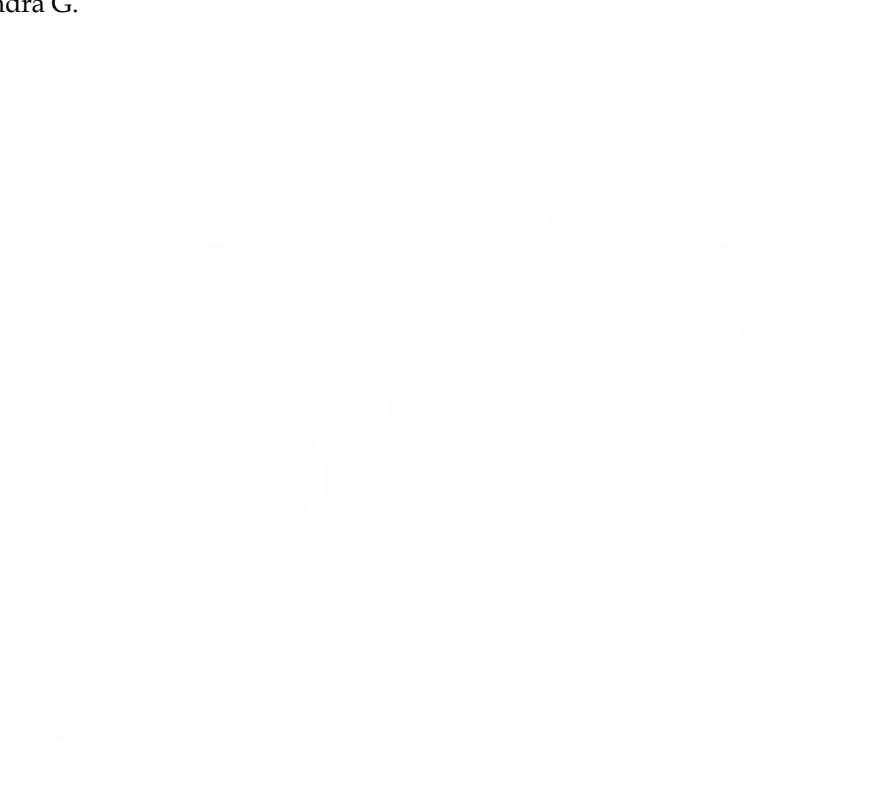

## Internet use 'good for the brain'

For middle-aged and older people at least, using the internet helps boost brain power, research suggests.

A University of California Los Angeles team found searching the web stimulated centres in the brain that controlled decision-making and complex reasoning.

The researchers say this might even help to counteract the age-related physiological changes that cause the brain to slow down.

The study features in the American Journal of Geriatric Psychiatry. As the brain ages, a number of changes occur, including shrinkage and reductions in cell activity, which can affect performance.

It has long been thought that activities which keep the brain active, such as crossword puzzles, may help minimise that impact - and the latest study suggests that surfing the web can be added to the list.

Lead researcher Professor Gary Small said: "The study results are encouraging, that emerging computerised technologies may have physiological effects and potential benefits for middle-aged and older adults.

"Internet searching engages complicated brain activity, which may help exercise and improve brain function."

The latest study was based on 24 volunteers aged between 55 and 76. Half were experienced internet users, the rest were not. Compared with reading each volunteer underwent a brain scan while performing web searches and book-reading

tasks.

Both types of task produced evidence of significant activity in regions of the brain controlling language, reading, memory and visual abilities.

However, the web search task produced significant additional activity in separate areas of the brain which control decision-making and complex reasoning - but only in those who were experienced web users.

The researchers said that, compared to simple reading, the internet's wealth of choices required people to make decisions about what to click on in order to get the relevant information.

However, they suggested that newcomers to the web had not quite grasped the strategies needed to successfully carry out a web search.

Professor Smith said: "A simple, everyday task like searching the web appears to enhance brain circuitry in older adults, demonstrating that our brains are sensitive and can continue to learn as we grow older."

Rebecca Wood, chief executive of the Alzheimer's Research Trust, said: "These fascinating findings add to previous research suggesting that middle-aged and older people can reduce their risk of dementia by taking part in regular mentally stimulating activities.

"Older web users - 'silver surfers' - are doing precisely this.

"Frequent social interactions, regular exercise and maintaining a balanced diet can also reduce dementia risk."

Dr Susanne Sorensen, head of research at the Alzheimer's Society, said: "Use it or lose it may well be a positive message to keep people active but there is very little real evidence that keeping the brain exercised with puzzles, games or other activities can promote cognitive health and reduce the risk of dementia."



### ECSE

#### Eastern Caribbean

On the ECSE, shares of Bank of Nevis, Cable & Wireless St Kitts Nevis, Grenada Electricity Services Limited, Grenreal Property Corporation Limited, S L Horsford & Company Limited and TDC traded all holding firm on their respective previous market close prices. 254 Dominica Electricity Services shares traded at \$3.04 closing up over 16% while SKNB traded at a high of \$3.00 and closed the week at \$2.99.

Also, the Government of St Vincent and the Grenadines' 91-day, \$20.0 million Treasury bill issue, was oversubscribed resulting discount rate was 5.82 per cent.

#### TRINIDAD:

On the TTSE, only 6 stocks advanced while 15 declined. Sagcor was the volume leader followed by Guardian Holdings which also registered the largest price drop of \$2.83 for the week. On the other hand West Indian Tobacco Company recorded the biggest upward price movement of \$1.01.

Inflation in T&T continues to increase, jumping to 11.9 per cent at the end of July from 11.3 percent at the end of June, according to the Central Bank of Trinidad & Tobago. Food inflation remains the chief culprit, as it continues to rise, going up by

25.3 per cent in July from 23.1 per cent at the end of June, while core inflation, which filters out the impact of food prices, went down slightly to 6.2 percent at the end of July from 6.4 per cent in June.

#### JAMAICA:

There were mixed results on JSE last week, as the JSE Market Index closed up, while the JSE Select and All Jamaican Composite Indices closed down. Jamaica Broilers led advancers closing up more than 9 percent while Desnoes & Geddes Limited, the biggest loser for the week, closed down more than 8 percent. Jamaica Broilers was also the volume leader accounting for more than 34 percent of the total weekly activity.

Brand Jamaica stocks are posting gains over 300 per cent outperforming the returns offered by alternative investment clubs. Those who invested in fashion, coffee, rum, real estate or hotel stocks since August last year are now reaping the highest capital gains on the market. Alternative investment schemes offered returns of some 10 per cent a month. However, since earlier this year investors have not been able to gain easy access to their money following the restructuring or fall-out of these institutions.

#### BARBADOS:

Over in Barbados, the local and composite indices closed down as the Regular Market

traded a total volume topping 94,000 shares. FCIB was the volume leader for the week, accounting for almost 30% of total volumes traded and holding firm at \$3.95. Other actively traded stocks included Insurance Corporation of Barbados Limited and Fortress Caribbean Property Fund, both closing down by 25 cents and 5 cents respectively.

A.M. Best Co., the global full-service credit rating agency, has affirmed the financial strength rating of 'A' (Excellent) and issuer credit rating of 'A' of Scotia Insurance (Barbados) Limited. The outlook for both ratings is stable. The ratings acknowledge Scotia's consistently solid operating performance, favorable capitalization and ample liquidity.

#### INTERNATIONAL:

Internationally, U.S. stocks fell for a second week as an advance in oil prices and lower-than-estimated earnings at Dell Inc. spurred concern a yearlong drop in profits isn't over.

The dollar posted its biggest monthly advance against the Euro since its 1999 debut on evidence economic weakness that began in the U.S. has spread. And finally, Crude oil was little changed as Hurricane Gustav approached the Gulf of Mexico, amid speculation that energy producers are better prepared to face a hurricane than when Katrina struck in 2005.

## West Ham appeal to CAS over Tevez

West Ham have appealed to the Court of Arbitration for Sport as they attempt to avoid a huge payout to Sheffield United in the Carlos Tevez affair.

CAS will now examine whether it has jurisdiction to hear the case, although a decision on this is not expected until the end of November.

The Lausanne court initially stated its rules would not allow an appeal.

Yet the fact it is willing to hold a preliminary hearing into its jurisdiction offers hope to West Ham.

A three-man panel will now decide whether CAS can hear the case.

One arbitrator was supposed to be provided by each club with the third member, the chairman, being nominated by CAS.

Yet while West Ham have provided an arbitrator, Sheffield United have not, meaning CAS will

appoint this member as well.

West Ham are expected to argue that FA rules would be in breach of Fifa statutes if they did not allow for an appeal to CAS.

Last month, CAS secretary general Matthieu Reeb told BBC Sport: "As things stand, CAS would not be able to hear this case. "We would need agreement from Sheffield United and for Football Association rules to allow an appeal to CAS."

The Blades would be reluctant to give agreement to an appeal that could overturn the decision of the independent tribunal.

And the FA actually has a rule that stipulates there cannot be an appeal from the verdict of an independent tribunal.

An independent tribunal ruled West Ham broke Premier League rules when they played Tevez at the end of the 2006/7 season and that he then went on to play a key role in keeping them up.

Sheffield United are claiming more than £30m in compensation from the Hammers.

## Cricket

### England to use Test appeal system

Players will be able to formally query umpiring decisions in England's Test series against the West Indies in 2009.

The umpire decision review system - first trialled in India and Sri Lanka's recent series - allows a team up to three unsuccessful appeals per innings.

England's tour to the Caribbean, which begins in January, will be one of four where the experiment will be used.

The decision was made by International Cricket Council (ICC) board members at their two-day meeting in Dubai.

England play four Tests in the Caribbean in February and March 2009 while the other three series which will

use the system before the ICC's cricket committee meets in May are New Zealand v West Indies, India v Pakistan and South Africa v Australia.

The ICC board also considered an application from the controversial Indian Cricket League (ICL), seeking approval for their competition, at the sitting.

However, a decision was adjourned pending further discussions between Shashank Manohar, president of the Board of Control for Cricket in India, and ICL officials.

The ICC board has agreed to look at possible changes to bilateral tours, including an enhanced Test championship, and to undertake further research into whether there should be an application to have cricket included in the 2020 Olympics.

It was further agreed that next April's ICC World Cup Qualifier should be moved from the Middle East to South Africa, pending that country's governing body's permission, after the Emirates Cricket Board admitted not all venues would be ready in time.
