AMERICANS, TIME TO WARM UP FOR NINTENDO'S Wii Fit

Now, with Wii Fit's U.S. debut inching ever closer, it's time for American gamers to start stretching and warming up. But what is Wii Fit? And why is it being seen as the next big product launch from Nintendo?

What makes Wii Fit unique is its electronic balance board that responds to players' movement and weight.

Built-in sensors track the side-to-side and front-to-back movements of the player to control the actions of the player's avatar on screen. Unlike other popular video games that emphasize role-playing, stealth, warfare, or the supernatural, Wii Fit stresses aerobics, strength training, and muscle-toning exercises.

Wii Fit will use the Body Mass Index (BMI) as the key metric to monitor your progress toward a healthier lifestyle.

The BMI is a standard measure of body fat supported by the World Health Organization and the National Institute of Health.

based on height, age, and weight, so after you register the first two metrics, you step onto the balance board to record your weight. Don't worry -- the Wii Fit balance board is rated to at least 300 pounds, so step right up.

In addition to establishing your BMI, Wii Fit will also put you through an initial series of activities to test and grade your ability to balance the left and right sides of your body.

Standing on the board and shifting your weight in all directions is essential to almost all of the Wii Fit games and physical activities. It will then assign you a Wii Fit age, another metric the software uses to record the progress toward your fitness goals.

Of course, the entire point of Wii Fit is that you're going to have to put in consistent, periodic

physical effort to stay in shape. To keep you interested and on track, Wii Fit has an impressive list of 40 activities and games that are organized into four main categories: strength training, aerobics, balance games and yoga.

Strength training consists of familiar exercises such as push-ups, lunges, leg extensions, and other activities common to most workouts. You do these by starting with various parts of your body on the balance board depending on the exercise.

With lunges, for example, one leg is on the board and the other is behind you on the floor, so you actually lean into the lunge. Wii Fit analyzes frequency, balance and form.

The aerobics set includes basic cardiovascular activities, such as simple dance step routines, rhythmic boxing workouts and some light jogging, in which you run through a virtual countryside circuit.

There's also a hula hoop game that's fairly strenuous -- you stand on the balance board and by shifting your weight, try to catch hula hoops on outstretched arms and then keep them all rotating around your hips.

Yoga is an intriguing training choice for Wii Fit, and anyone familiar with the regimen of meditative movement, stretching, and breathing can tell you that it's much harder than it looks.

But Wii Fit makes learning the classic forms of yoga look simple. An onscreen avatar teaches you the forms, and lets you know how steady -- or unsteady -- you actually are.

The balance activities reveal the Wii Fit offerings that are most like traditional video games. There's a soccer heading game, ski and snowboard slaloms, and even tightrope walking.

The table tilt is a variation on a tilt-board game where you stand on the balance board and lean in all the right directions to guide multiple balls across a maze-like obstacle course.

The system also acts as a personal trainer of sorts by offering verbal and visual feedback, both encouragement and criticism.

If you can handle the truth about your body according to Wii Fit, it's prepared to be your personal trainer and fitness coach, attributes that some think could mean blockbuster sales for the game and hardware bundle.

But what might hold the real key to Wii Fit's popularity in the mass market is its ability to record and track changes to your body over time.

You can monitor daily, weekly, or monthly progress using easy-to-comprehend graphs and charts displayed on your TV. Moreover, Wii Fit asks you to set fitness goals and to periodically check your progress.

By viewing the BMI and Wii Fit age data such as weight fluctuation over time, Nintendo hopes people will learn to judge what they should and should not do to manage weight and health.

At a recent event in San Francisco, California, Nintendo producers demonstrated the title. The game's lead U.S. producer discussed how Wii Fit helped him address a topic he's chronically avoided, managing his weight, as well as dealing with personal goals of staying in shape and healthy at home and on the road.

That openness, the executive said, is emblematic of Nintendo's core goals with the game: to make health and fitness something individuals and families talk about more often, and with greater candor



ECSE

Eastern Caribbean

The Eastern Caribbean Securities Exchange yielded mixed results on the secondary market after trading of three stocks namely, Cable & Wireless St.Kitts & Nevis which traded at \$7.50, ECFH which closed at \$15.00 and TDC which traded down 50 cents at \$13.00.

The Government of Antigua & Barbuda successfully auctioned EC\$17 million of 91 day Treasury Bills. The auction closed at a discount rate of 5.20%, 80 basis points less than its last closing rate of 6.00%.

In related news, Cable & Wireless St.Kitts & Nevis' primary market auction of over 1.6 million shares was oversubscribed by almost 900,000 shares. The shares were sold at an offer price of \$5.00 per share.

TRINIDAD

In Trinidad, the markets continued to rally closing the week with an advance decline ratio of 11 to 1. Winners included Ansa Mcal, Sagicor and Republic Bank. The only two declining stocks were Angostura Holdings and Agostini's Ltd.

JAMAICA

Jamaican indices ended the week with mixed results as the Market and All Jamaica Indices declined while the JSE Select advanced slightly. Losers outnumbered winners 5 to 4. Advancers included Grace Kennedy and Trinidad Cement while Guardian Holdings, FCIB and RBTT closed on the downside.

BARBADOS

On the Barbados Stock Exchange, Barbados Shipping & Trading, Sagicor & Banks Holdings led trading volumes for the week. Market indices were in positive territory as 3 stocks advanced and none declined. The three winners were Light & Power Holding, Sagicor & Cave Sheperd.

First quarter results for the Trinidad, Jamaica & Barbados exchanges have been released and the Trinidad market emerged best performer. The Trinidad Composite Index recorded positive returns of 1.1 per cent, compared to the same periods of 2006 and 2007 when it was down over 10 per cent and 4 per cent respectively. In the Jamaican market, the JSE Main Index closed in negative territory after ending 7.24 per cent up in 2007. While the Barbados Stock Exchange closed 2007 as the best performer, it was the worst performer over the last three months, with the BSE Local and the BSE Composite down 0.87 per cent and 0.35 per cent respectively.

INTERNATIONAL

On the international front Finance chiefs from the Group of Seven nations, the G-7, signaled concern on the dollar's slide. The officials met after the International Monetary Fund last week estimated a 25 percent chance of a global recession this year. Against the euro, the dollar fell 0.6 percent and against the Yen, the U.S. currency dropped 0.7 percent. The downgraded outlook for the world economy has been blamed on the U.S. housing recession, credit-market turmoil, high commodity prices and inflation pressures. The G-7 pledged to implement further monetary and fiscal policies to help reverse the US dollar's slump.

On April 17 CMMB will host the final in its 12-Series Intelligent Investing Seminars, at the Bay Gardens Hotel. This final seminar in the series will focus on International Securities Trading. Sammy excited by St Lucia match

Darren Sammy, the first international cricketer to come from St Lucia, says he cannot wait for his first chance to play an ODI in front of his home crowd. West Indies are hoping to complete a 3-0 whitewash when they take on Sri Lanka in the final game of the series at Beausejour Stadium on Tuesday.

The occasion will be extra special for Sammy, who has played 12 one-day internationals, and for the St Lucian fans, who he is certain will turn out in big numbers. "It's an amazing feeling for me although it hasn't happened as yet," Sammy said. "As a little boy you dream to play an international game in front of your home crowd."

"Tomorrow could be that opportunity for me, it would be a momentous occasion for me and all St Lucians. I know they will

come out to support me and the West Indies team so I'm looking forward to play in front of my home crowd."

Sammy picked up one wicket and scored one run in the two matches against Sri Lanka in Trinidad and he will be desperate to lift his output on such an important personal occasion. "Any time I wear any cricket jersey I'm under pressure," he said. "This is not anything new to me but this time around I know the stadium will be packed, it will be a little added pressure but this is something, as a professional, you

have to learn to deal with. I won't let my emotions take the better of me."

Victory in St Lucia would leave West Indies with a 3-0 ODI triumph after they came back from 1-0 down to draw the Test series against Sri Lanka 1-1. "It is a long time since West Indies has had a chance to complete a whitewash and as the coach [John Dyson] said we're looking to do that tomorrow," Sammy said. "If our guys continue to execute whatever plans we set out I see no reason why we shouldn't complete the whitewash."

Manchester, England (Sports Network) - Manchester United's Carlos Queiroz has warned Real Madrid that they have no chance of prising Cristiano Ronaldo away from Old Trafford.

The 23-year-old Portugal winger has been linked with moves to the Bernabeu during the past two summers with reports suggesting Real will renew their interest this year after his stunning season.

Ronaldo has scored 38 times for the Red Devils so far this season and is expected to be named both the PFA Player of the Year and the club's stand out performer.

However, Queiroz is adamant that no amount of money will persuade United to part with their prize asset.

Instead the Old Trafford club are believed to be preparing a new long-term contract for the former Sporting Lisbon youngster.

"We would not sell him for (\$190 million)," Queiroz told Marca. "You can offer all the money in the world, but there is no amount that can buy him."
