APPLE MACBOOK AIR ULTRAPORTABLE LAPTOP



The MacBook Air is a super-slim ultraportable laptop computer that you can slip into very thin spaces. Like anything else that Apple crafts, the Air's industrial design is phenomenal. But its beauty is little more than skin deep.

The Air's looks can't be denied, but its performance and expandability are whole other matters

Miraculously, the Air houses a 13.3-inch, 1280-by-800-pixel display; a roomy keyboard; and a double-wide, multitouch trackpad within its petite, 0.75-inch-thick frame. But aside from a headphone jack, a USB port, and a mini-DVI port, it's not very well equipped. It lacks an optical drive, and to connect to a network via ethernet, you must purchase a \$29 USB adapter.

Starting at \$1700, you're paying a lot for the Air's style. At that price, the Air comes with a traditional, 80GB platter-based hard drive, but for an extra \$1000, you can get a 64GB solid state drive. That raises the Air's price to that of the much-better-equipped Lenovo ThinkPad X300.

The Air's anodized brushed-aluminum casing is cool to the touch, and even the most anti-Mac person can't help but appreciate it. The gorgeous keyboard's cut-out key design is not only unique, it provides huge keys that feel great to the touch. They are also amply spaced so that you won't find yourself bumbling over hitting the wrong keys.

You won't have trouble seeing the keys in dark rooms, either, because thanks to an ambient light sensor, the Air adds a subtle background glow to the keyboard when it gets dark. That feature works in the preinstalled Mac OS, of course, but not in Vista.

In the Mac OS, the enormous touchpad adorning the laptop's bottom recognizes multitouch commands, much as the iPhone's interface does--use two fingers pinching inward to zoom in, or stroke across the top to navigate pages, and so on. The feature is neat to see in action, but I'd consider it a bigger deal if Synaptics hadn't already delivered drivers that provide somewhat similar functionality for many Windows-based trackpad-based notebooks.

Despite having a 1.6-GHz Intel Core 2 Duo L7500 (that's a relatively powerful CPU for an ultraportable), the Air scored behind some of the ultraportable notebooks in its 3-pound weight class--even ones that had slower processors. After we installed Apple's Boot Camp software and Windows Vista,

the Air earned a 57 on our WorldBench 6 tests. Lenovo's ThinkPad X300, a business-oriented notebook, has a lower-powered CPU (a 1.2-GHz Core 2 Duo L7100), and yet scored a 64 on WorldBench--a significant 12 percent difference. You might suspect that the Air's being a Mac might have something to do with it--and perhaps it did, but previous Apple notebooks haven't had any performance issues on WorldBench, and in fact, for a time a MacBook Pro held the title of the fastest notebook we'd tested.

We also ran into some initial speed bumps with the Air (specifically, getting hardware-related function keys to work, such as those for the volume and brightness controls), but Apple's Boot Camp utility resolved some of the stickiest problems. However, this lightweight is light on run times: In our lab tests, the Air's battery lasted for 2.5 hours of operation. And because of its closed-case design, you can't swap in a new battery. So, what at first seems a godsend if you're a frequent flyer will quickly ground you-unless, of course, you fly first-class on those planes now offering power outlets.

Ultimately, though, the air is a victory of industrial design and single-minded purpose. It has decent performance for an ultraportable, but few standout features to speak of beyond the superficial. And yet, I still can't help wanting to stop and touch it.

The TTSE recorded an advance decline ratio of 16 to 8 last week. Neal & Massy recorded the biggest upward price movement, advancing by \$1.64, while Scotiabank led the decliners. NCB Jamaica emerged volume leader followed by Sagicor and RBTT, with the three accounting for 48% of total volumes traded.

Rum and other spirits sales increased for Angostura, but a once-lucrative business deal gone sour led to the company posting a \$137.3 million after-tax loss in 2007. The net loss means that Angostura shareholders will receive no further dividends for that financial period.

JAMAICA

In News from Jamaica, all three JSE indices advanced. Of the 36 stocks traded, 18 advanced, 10 declined and 8 traded firm. Jamaica Broilers Ltd. was the volume leader with over 20% of the week's activity followed by Gleaner Company and Supreme Ventures Limited.

Having not secured a replacement for Danish shipping firm, Maersk, the Port Authority of Jamaica is seeing its volumes fall off even while costs and capacity rise. The Port's total income increased marginally over the review period, resulting in a \$200 million reduction in operating surplus.

BARBADOS

All three Barbados indices advanced last week. The Regular Market traded a total volume topping 702,000 shares. The top three traded companies were Banks Holdings Limited which accounted for the bulk of the activity at 76%, followed by Neal & Massy Holdings and Sagicor Financial Corporation.

In related news, Sagicor has put shareholders on notice that America's sub-prime mortgage crisis and economic recession will likely impact the markets in which the Barbados-based company operates. Sagicor's chairman warned that the company could soon be feeling the pinch from the US economic slowdown which was expected to last throughout 2008. He also noted the company fell short in attaining the group's revenue target as a result of one of its US based subsidiaries failing to meet its own revenue target.

INTERNATIONAL

Internationally, U.S. stocks posted the biggest weekly gain in almost three months after oil prices reached new highs and Google, Intel and JP Morgan reported better-than-expected earnings.

The dollar touched an all-time low against the euro on speculation the European Central Bank won't follow the Federal Reserve in cutting interest rates.

Rice futures rose for a fifth day, recording the biggest weekly advance in at least seven years, on concern export curbs imposed by China and Vietnam will spread as importing nations struggle to meet their needs.

And finally, crude oil and gasoline climbed to records as better-than-expected earnings signaled a strengthening US economy that may boost demand.

Gayle doubtful, Burdett refuses

Gayle out?

Chris Gayle has been ruled out of the first edition of the Indian Premier League after failing to recover from a groin injury that he sustained during the recent series against Sri Lanka, the Kolkata based Telegraph reported. However, he will be in Kolkata in the first week of May to spend some time with the team. The franchise are yet to name a replacement.

However a spokesman for the franchise said a final decision was yet to be made. "He's injured but he's still not out of the tournament," he said. "No decision has been made yet."

Gearing up on a centre-pitch

Both the Mumbai Indians and Chennai Super Kings were allowed centre-wicket practice on the eve of the match, it was reported. Mumbai, who practised second, were initially asked to use the adjoining net facilities but the moment they realised that their opponents had used the one of the centre strips, they demanded similar facilities too. "The match won't be played on the pitch on which the teams are practising. It will

take place on the pitch adjacent to it," one of the TNCA officials was quoted as saying in the Times of India.

Burdett turns down SOS

The Kolkata franchise sent out an SOS to South Australia's 57-year-old chief curator Les Burdett but he is unlikely to oblige, the Asian Age reported. Burdett, who is vacationing with his family in the outback, said: "I can't come to India now for few days at least. I am enjoying my holiday and I have recently returned from your country where I inspected the pitches (at Mohali and other centres). For a few more days I can't leave Australia again."

The bad blood ain't over

Though they may share the same dressing room for the Kolkata Knight Riders, Ishant Sharma has emphasised there will be no comradeship with Ricky Ponting when the two face-off against each other while playing for their countries. "It is a privilege to share dressing room with a great player like Ponting," Ishant said. "We discussed cricket and joked at each other at the dressing room, we are just like friends now. But it is not that I won't show aggression at him while playing for India against Australia."

The spell that Ishant bowled to Ponting at the WACA was one of the highlights of India's tour to Australia. "No colour comes before you when

you are donning your national colours. I will give back if I am provoked and the same thing had happened in the Australia series."

Champions League Semi-Final First Leg

Barcelona star Thierry Henry has recovered from illness and could start alongside Lionel Messi and Deco in the Champions League semi-final, first leg.

Ronaldinho is injured but skipper Carlos Puyol is banned so Rafael Marquez is set to play in defence.

Manchester United defender Nemanja Vidic, who has just returned to action after a knee injury, is doubtful.

Wes Brown is also a concern but Edwin van der Sar, Wayne Rooney, Owen Hargreaves and Anderson are all fit.

England striker Rooney has overcome the hip injury he suffered on Saturday, while Hargreaves and Anderson sat out the draw with Blackburn to allow them to recover from minor knocks.

Vidic missed United's training session at the Nou Camp on Tuesday so Spaniard Gerard Pique is standing by to replace the Serbian international.

Messi, the 20-year-old Argentine striker and Barca's leading player this season, has made just two appearances as a substitute since returning to action after six weeks out with a thigh injury.

Former Arsenal star Henry, who was

an unused substitute in Saturday's goalless draw with Espanyol, returned to training on Tuesday after sitting out Monday's session because of a fever.

Portuguese midfielder Deco has overcome a calf injury but is still building up his fitness.

"Messi is progressing well and could start. Henry has been with the team on Tuesday and we will see how he is in the training session.

"Deco is OK too, he has worked hard in the last few training sessions," said coach Frank Rijkaard.

Mexican defender Marquez has been suffering from bruising and inflammation in his right foot but seems set to partner Gabriel Milito in the centre of defence.
