2. Conceptualises and develops coherent and coordinated research and policy initiatives and documents by keeping abreast with development in the global and macro-environment and maintaining a robust feedback loop for research to inform and support informed decision-making and the strategic intent of the Department.
3. Provides strategic advice to the Permanent Secretary/ Director of Finance on the implications of financial and economic policies, trends, and risks by analysing, producing and summarising complex data to ensure access to relevant information.
4. Leads and directs research and analysis for the production of the Annual Economic and Social Review by providing expert technical advice and implementing content validation measures to facilitate timely submission to Parliament and publication.
5. Provides strategic advice and guidance on macro-economic policy matters through Memoranda to

Cabinet to aid good decision-making and good governance.

6. Collaborates with the Budget Director in the compilation of the Estimates of Revenue and Expenditure by conducting economic and financial analysis and providing information and advice, to facilitate the production of an Appropriations Bill which accurately reflect the government's policy priorities;

LAND ACQUISITION ORDINANCE (CHAPTER 5.04)

IN THE MATTER of a Declaration by the Governor General acting on the advice of Cabinet that a Parcel of land situate at Bexon, Quarter of Castries in the island of Saint Lucia is likely to be acquired for a public purpose.

DECLARATION OF ACQUISITION OF LAND

Whereas, it is enacted by Section 3 of the Land Acquisition Ordinance Chapter 5.04 that if the Governor General acting on the advice of Cabinet considers that any land should be acquired for a public purpose, he may cause a Declaration to that effect to be made;

And Whereas, it is considered by the Governor General acting on the advice of Cabinet that the lands mentioned and described in the Schedule hereto should be acquired for a public purpose to wit: **Resolve flooding issues at the Deglos/Bexon junction.**

Now Therefore, it is hereby declared by the Governor General acting in accordance with the advice of Cabinet, that upon the Second Publication of this Declaration in the Gazette, the lands mentioned in the schedule hereto shall be vested absolutely for a public purpose to wit: **Resolve flooding issues at the Deglos/Bexon junction.**

SCHEDULE 1
