LOBSTER FISHERY CLOSED

The Department of Fisheries informs that the Lobster Fishery will be **CLOSED** from **March 1, 2018** until **August 1, 2018, both days inclusive**. When the Lobster Fishery is closed it is illegal for anyone to have lobsters in their possession.

According to Section 32, (2) (d) of the Fisheries Act Cap 7.15, of the Revised Laws of Saint Lucia 2013 "*a person shall not, fish for, remove from the fishery waters, give, or at any time have in his or her possession, expose for sale, sell or purchase any lobster*" when the lobster fishery is closed.

Members of the public, fishers, vendors and restaurant establishments that fail to comply with the requirements of the lobster season threaten the sustainability of the lobster population. As such, **non-compliance with the lobster closed season may result in the extended closure**.

The laws protecting lobsters are key tools in ensuring that lobsters can continue to provide valuable income for local fishers, vendors and restaurateurs as well as a source of protein for the general public.

The general public, especially purchasers and consumers are advised that they **SHOULD NOT** purchase lobster during March 1, 2018 to April 1, 2018 when the lobster fishery is closed. Anyone caught violating the Fisheries Regulations may be fined up to EC\$5000.00 for each offence. Reports can be made to the Marine Police at Tel #: 456-3870, the nearest Police Station or the Department of Fisheries.

The *Saint Lucia* [has received financing from the World Bank toward the cost of the **SAINT LUCIA - SOLAR PV DEMONSTRATION AND SCALE UP Project** and intends to apply part of the proceeds toward payments under the contract for the **Supply and Installation** of Solar-Photovoltaic (PV) Array for the EU Owen King Hospital (National Hospital), Millennium Highway, Castries, Saint Lucia.

The *Department of Economic Development Transport and Civil Aviation* now invites sealed bids from eligible bidders for a *Solar P V Systems* with a capacity of 200k W or better, using conceptual array plans ranging from 60 cell modules to 72-cell modules with racks *to be installed on four roofs* at EU Owen King Hospital (National Hospital), Millennium Highway, Castries, Saint Lucia; delivery of the equipment should be completed within sixteen weeks and installation completed within six months of contract effectiveness.

PRESS RELEASE

The Development Control Authority (DCA) under the Physical Planning and Development Act is responsible for land development in Saint Lucia. Under this authority, the DCA has been monitoring developments along the road reserves throughout Saint Lucia. The function of the road reserve is to facilitate services such as power lines, street lights, water distribution networks, pedestrian sidewalks, accesses to properties, road widening, traffic lights, traffic signs and traffic lines of sight, bus stops and vehicle laybys.

However, over the past few years the Authority has observed that the road reserves have become inundated with unauthorized vending activities including advertisement signs and displays. This has caused significant disruptions to the intended uses and users of the reserve. In an effort to address this concern the Authority will be undertaking a cleanup campaign of the road reserves by removing unauthorized uses including advertisement signs and vending.

This campaign will commence 15th February, 2018 in the north of the island and will include the Castries/ Gros Islet Highway from the entrance into Cap Estate to the La Toc Roundabout, the Rodney Bay main road and minor roads, the Bonne Terre main road to Callie Manger, the Monchy main road, the Mongiraud main road, the Bois D'Orange main road, the main and bypass roads to Corinth and Marisule, the Allan Bousquet Highway,

the Vigie round about and stretch, the John Compton Highway and the roads within the city of Castries. The campaign will thereafter move to Vieux Fort followed by other areas around Saint Lucia.

The DCA will be undertaking this activity in conjunction with the Crown Lands Section of the Department of Physical Planning, the Department of Infrastructure and the Royal Saint Lucia Police Force.
