IN an effort to improve the services to importers, the St. Lucia Customs and Excise Department reminds all Cargo Agents of their responsibility pursuant to Section 25 of the Customs (Control and Management) Act Cap 15.05 of the Laws of St. Lucia (the Customs Act). Accordingly, the master of every vessel shall deliver a report to the Comptroller of Customs 24 before the arrival of vessels. The commander of every aircraft shall deliver a report to the Comptroller of Customs before arrival of aircraft. Agents for cargo vessels and aircraft include:

- Ships Agents
- · Airline Agents
- Courier Companies
- Non Vessel Operating Cargo Consolidators (NVOCC)

Effective January 01, 2021, the Department will strictly enforce the provisions of Section 25 of the Customs Act. This will ensure that importers are able to prepare their Declarations in time to clear goods out of Customs Charge upon arrival.

Section 25, also provides for the amendment of manifests to correct the contents within 24 Hours of submitting the reports. Failing to comply with the provisions of the Customs Act will result in penalties.
