- At 8:59 a.m. the Last Post will be sounded.
- Two (2) minutes of silence will be observed at the War Memorial on Derek Walcott Square at 9:00 a.m.
- His Excellency the Governor General will give a brief address followed by a short National Service during which prayers will be said by representatives from the Roman Catholic Church, the Anglican Church, the Methodist Church and the Salvation Army.
- The Act of Remembrance will be recited by the Ex-Servicemen League.
- His Excellency the Governor General will lay a wreath at the foot of the memorial on behalf of the State.
