AN ACT to amend the Gaming, Racing and Betting Act, Cap. 13.13.

[3rd August, 2020]

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the House of Assembly and the Senate of Saint Lucia, and by the authority of the same, as follows:

No. 7] *Gaming, Racing and Betting (Amendment) Act* [2020

Short title

1. This Act may be cited as the Gaming, Racing and Betting (Amendment) Act, 2020.

Amendment of section 22

2. Section 22 of the Gaming, Racing and Betting Act, Cap. 13.13 is amended —

- (a) by deleting subsection (12) and by substituting the following —

“(12) Notwithstanding subsection (11), Cabinet may grant a gaming operator licence in respect of premises at which gaming is to take place, which is not a hotel containing two hundred and fifty rooms, if at least one hundred persons will be continuously employed at the premises.”;

- (b) in subsection (13), by deleting the words “does not employ at least 200 persons” and by substituting the words “does not continuously employ at least one hundred persons”.

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the House of Assembly and the Senate of Saint Lucia, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the Styrofoam and Plastic Food Service Containers (Prohibition) (Amendment) Act, 2020.

Interpretation

2. In this Act, “principal Act” means the Styrofoam and Plastic Food Service Containers (Prohibition) Act, No. 22 of 2019.

Amendment of section 5

3. Section 5(1)(b) of the principal Act is amended by deleting the words “1st day of August, 2020” and by substituting the words “1st day of August, 2021”.

Amendment of section 6

4. Section 6(1) of the principal Act is amended —

- (a) in paragraph (a), by deleting the words “1st day of August, 2020” and by substituting the words “1st day of August, 2021”;
- (b) in paragraph (b), by deleting the words “1st day of August, 2021” and by substituting the words “1st day of August, 2022”.

Amendment of section 7

5. Section 7(1) of the principal Act is amended —

- (a) in paragraph (a), by deleting the words “1st day of August, 2020” and by substituting the words “1st day of August, 2021”;
- (b) in paragraph (b), by deleting the words “1st day of August, 2021” and by substituting the words “1st day of August, 2022”.
