# BY HIS EXCELLENCY THE GOVERNOR GENERAL

#### A PROCLAMATION

SIR EMMANUEL NEVILLE CENAC GCSL., GCMG., GOVERNOR GENERAL.

**WHEREAS** it is enacted by section 17(1) of the Constitution of Saint Lucia, Cap. 1.01 that the Governor General may, by proclamation which shall be published in the *Gazette*, declare that a state of emergency exists for the purposes of Chapter 1 of the Constitution of Saint Lucia, Cap. 1.01;

**AND WHEREAS** section 17(2) of the Constitution of Saint Lucia, Cap. 1.01 provides that a proclamation under section 17(1) shall not be effective unless it contains a declaration that the Governor General is satisfied —

- (a) thatapublicemergencyhasarisenasaresultoftheimminence of a state of war between Saint Lucia and a foreign state;
- (b) that a public emergency has arisen as a result of the occurrence of any earthquake, hurricane, flood, fire, outbreak of pestilence or of infectious disease, or other calamity whether similar to the foregoing or not; or
- (c) that action has been taken, or is immediately threatened, by any person, of such a nature and on so extensive a scale, as to be likely to endanger the public safety or to deprive the community or any subtantial portion of the community of supplies or services essential to life;

Constitution of Saint Lucia - Proclamation for Revocation of Declaration of State of Emergency

**AND WHEREAS** by virtue of section 17(1) and (2) of the Constitution of Saint Lucia, Cap. 1.01 the Governor General, by proclamation, declared a state of emergency for the purposes of Chapter 1 of the Constitution of Saint Lucia, Cap. 1.01, published in the *Gazette* on the 23<sup>rd</sup> day of March, 2020 as the Constitution of Saint Lucia – Proclamation for Declaration of State of Emergency, Statutory Instrument, No. 39 of 2020;

**AND WHEREAS** by virtue of section 17(3) of the Constitution of Saint Lucia, Cap. 1.01 Parliament, approved the declaration of a state of emergency that was published in the *Gazette* on the 23<sup>rd</sup> day of March 2020 as Statutory Instrument No. 39 of 2020, by the Constitution of Saint Lucia – Resolution of Parliament Approving Declaration of State of Emergency, Statutory Instrument, No. 40 of 2020:

**AND WHEREAS** by virtue of section 17(6) of the Constitution of Saint Lucia, Cap. 1.01 Parliament —

- (a) extended for an additional period, the declaration of a state of emergency that was passed as Statutory Instrument, No. 40 of 2020, by the Constitution of Saint Lucia Extension of Resolution of Parliament Approving Declaration of State of Emergency, Statutory Instrument, No. 60 of 2020;
- (b) further extended for an additional period, the declaration of a state of emergency that was passed as Statutory Instrument, No. 40 of 2020, by the Constitution of Saint Lucia – Further Extension of Resolution of Parliament Approving Declaration of State of Emergency, Statutory Instrument, No. 78A of 2020;

**AND WHEREAS** it is enacted by section 17(4) of the Constitution of Saint Lucia, Cap. 1.01 that a declaration of a state of emergency may at any time be revoked by the Governor General by proclamation published in the *Gazette*;

**AND WHEREAS** the Governor General now considers it necessary to revoke the declaration of a state of emergency made under the Constitution of Saint Lucia – Proclamation for Declaration of State of Emergency, Statutory Instrument, No. 39 of 2020 with effect from the 30<sup>th</sup> day of September, 2020;

# Constitution of Saint Lucia - Proclamation for Revocation of Declaration of State of Emergency

**NOW THEREFORE I, EMMANUEL NEVILLE CENAC,** Governor General of Saint Lucia, by this Proclamation do hereby revoke the Constitution of Saint Lucia – Proclamation for Declaration of State of Emergency, Statutory Instrument, No. 39 of 2020 with effect from the 30<sup>th</sup> day of September, 2020.

**GIVEN** under my hand and the Public Seal of Saint Lucia at Government House in the City of Castries, in the State of Saint Lucia this 25<sup>th</sup> day of September, 2020 in the sixty-ninth year of the Reign of Her Majesty Queen Elizabeth the Second.

### Legal Profession (Eligibility) (Magali Guadalupe Marin-Young) Order

# SAINT LUCIA

STATUTORY INSTRUMENT, 2020, No. 150

[ 28th September, 2020 ]

WHEREAS it is provided under section 16(1) of the Legal Profession Act, Cap. 2.04 that the Attorney General may, by Order published in the *Gazette*, specify that a person who is a citizen or a national of a country other than Saint Lucia who has obtained the qualifications prescribed by law shall be eligible to be admitted by the High Court to the practice of law in Saint Lucia;

AND WHEREAS it is further provided under section 16(2) of the same Act that the Attorney General shall not make an Order unless the Attorney General is satisfied, after consultation with the Chief Justice, that the person is a citizen or a national of a country the laws of which give reciprocal treatment to a citizen of Saint Lucia in relation to admission to the practice of law in that country;

**NOW THEREFORE**, pursuant to section 16(1) and (2) of the Legal Profession Act, Cap. 2.04 and on being satisfied that Magali Guadalupe Marin-Young is eligible to be admitted by the High Court to the practice of law in Saint Lucia, the Attorney General makes this Order:

#### Citation

1. This Order may be cited as the Legal Profession (Eligibility) (Magali Guadalupe Marin-Young) Order, 2020.

#### **Eligibility**

**2.** Magali Guadalupe Marin-Young is declared eligible to be admitted by the High Court to the practice of law in Saint Lucia.
