# MINISTRY OF HEALTH & ELECTORAL DEPARTMENT COVID -19 RESPONSE PLAN FOR THE CONDUCT OF THE

This COVID -19 RESPONSE PLAN is prepared by the Saint Lucia Electoral Department in consultation with and under the guidance of the Ministry of Healthfor the 2021 General Elections, pursuant to the provisions of:

2021GENERAL ELECTION IN SAINT LUCIA

- COVID -19 (Prevention and Control) Act No. 9 of 2020;
- Public Health Act Cap 11.01 Revised Edition of the Laws of Saint Lucia;
- Public Health (Amendment) Act No. 19 of 2019
- Statutory Instrument, 2020, No. 151
- Statutory Instruments published by the Minister of Health for protocols to be observed at Polling Stations during the taking of the poll.

The Response Plan is intended to assist the Ministry of Health in the prevention or control of the spread and transmission of Covid -19 virus and to safeguard the health and safety of citizens, during the conduct of the 2021 General Election.

#### 1. ELECTION PLANNING

In keeping with the legislation stated above, the department will inspect all premises to be used for the general election and in the conduct of the advance and general poll;

- Polling Station layout will be designed to ensure compliance with the protocols;
- Three feet (3') seating arrangements will be allowed ONLY for the election workers in the polling station;
- > Toilet facilities or frequently touched points, will be sanitized and disinfected after each use:
- Premises used as Polling Stations will be sanitized before and after polling activities;
- > All materials for use for the elections will be delivered to the office of the Returning Officer for onward delivery to the Presiding Officers, thereby reducing the number of contacts;
- > Transportation of election and other workers will comply with COVID-19 Protocols. Passengers and drivers must at all times wear face masks and hand sanitized before entering the vehicles;
- > The department, in collaboration with the Ministry of Health, will ensure that election workers undergo "Rapid Testing" in preparation for elections:
- Ministry of Health officials will be accredited by the Electoral Commission to serve as local election protocol complianceobservers.

### 2. VOTER EDUCATION/COMMUNICATION

- The department sought the Ministry of Health's assistance in developing the relevant messaging on COVID-19 for the general elections:
- > Extensive use was made of radio and television programmes and social media marketing in both English and Creole languages on the COVID-19 Protocols to be observed during the elections.

#### 3. TRAINING

- Training venues and procedures willcomply with COVID-19 Protocols;
- > The department will embark on a review of regulations, guidelines and manuals for election officials in the light of the protocols;
- ➤ Update all Election Information Kits to include COVID-19 Protocols;
- Training will combine face-to face and electronic approaches. Where the former is used, COVID-19 protocols will be applied.

## 4. NOMINATION DAY

- Only the candidate or his/ her duly appointed agent will be allowed entry into the office of the Returning Officer to deliver his or her nomination papers
- ➤ All COVID- 19 Protocols will be in full effect at the office of the Returning Officer.

#### 5. POLLING STATION ACTIVITIES

- > Thermal scannersmay be used at Polling Stations;
- ➤ The use of face masks is mandatory for all persons involved in the election process and must be worn at all election locations;
- Face masks and hand sanitizers will be provided to all election officials;
- > All protocols regarding physical distancing will be maintained;
- > There will be a queuing system within the 100 yards and beyond at the polling stations:

- Upon entry, voters will be sanitized;
- > Voters shall be requested to lower their mask for identification purposes;
- ➤ All furniture and equipment used at polling station will be sanitized periodically;
- > Voting booths will be sanitized after each voter use;
- > Voters will be provided with sanitized pencils;
- > Any person who does not have a face mask will be issued with a disposable mask before entering the Polling Station;
- Voters'hands will be sanitized before dipping the finger into the voting ink (no need to do so as hands already previously sanitized)
- ➤ The Presiding Officer, will sanitize his hands before examining a voter'sfingers
- Children will not be allowed at the polling stations;
- After a voter has cast his/her vote, he or she shall immediately leave the voting area taking allpersonal item(s) with them;

#### 6. CLOSE OF POLLS

- > At the close of polls, election officials will ensure that all materials are properly packaged and sanitized;
- The social distancing protocol must be maintained when observing the count:
- > At the close of polls, polling station staff will ensure that materials are properly disinfected/sanitized and carefully packaged.

#### 7. POST ELECTION ACTIVITIES

Post mortems will be preferably done virtually, where face-to-face sessions take place, the protocols for COVID-19 will be adhered to.

# **APPENDIX**

#### 1. Managing a sick employee:

A separate space or room must be identified for persons who appear to have developed respiratory illness symptoms (i.e. cough, shortness of breath) upon arrival to work or become sick whilst at work until he/she can be safely transported out of the polling station by medical personnel.

# 2. <u>Environmental Cleaning:</u>

- Vehicles
- Physical distancing:
- Maintain physical distancing between the driver and passengers and between passengers
- The maximum number of passengers must be limited to the number of passenger seats in the back of the vehicle and in accordance with local regulations
- A Transitvehicle should carry no more than 10 passengers each wearing a face mask.
- Cleaning and disinfecting vehicles, at the end of the work day and between every journey:
  - When cleaning the vehicle, persons should wear face mask and disposable gloves.

- Doors should remain open during the cleaning process
- Frequently touched surfaces should be thoroughly cleaned and disinfected using 0.5% sodium hypochlorite solution or commercially approved disinfectant.
- Clean interior of vehicle with neutral detergent
- Rinse the interior of the vehicle with a bleach solution of 1:10 bleach to water
- Allow the bleach solution to remain for 10 minutes
- Rinse thoroughly with clean water
- Allow the vehicle to air dry

# Cleaning and disinfecting polling premises:

- Design and implement a cleaning schedule and protocol for: Periodic cleaning within the day Cleaning at the change of shifts Cleaning at the end of the voting day Cleaning ofspills, body fluids etc.
- If surfaces are dirty/soiled, they should be cleaned and disinfected following the documented protocols, using a detergent or soap and water prior to disinfection.
- Use standard procedures for cleaning and disinfecting and use an Environmental Protection Agency (EPA) registered disinfectant.
- Using the proper concentrations of disinfectant and allow required wet contact time.

#### > Janitorial functions and Personal Protective Equipment (PPE):

- Cleaning staff should wear the recommended personal protective equipment including a minimal: disposable gloves and face mask
- Gloves should be compatible with the disinfectant products being used.
- Additional PPE might be required based on the cleaning/disinfectant products being used and whether there is a risk of splash.

- Gloves should be removed carefully to avoid contamination of the wearer and the surrounding area. Be sure to clean hands after removing gloves.
- Gloves should be removed after cleaning a room/isolation area occupied by persons.
- Clean hands immediately after gloves are removed.
- Cleaning staff should immediately report breaches in PPE (e.g., tear in gloves) or any potential exposures to their supervisor.
- Cleaning staff and others should clean hands often, including immediately after removing gloves.
