### No. 14 of 2023

**AN ACT** to provide for the services of the State of Saint Lucia for the year ending on the thirty-first day of March, two thousand and twenty-four.

[ 9th May, 2023 ]

**BE IT ENACTED** by the King's Most Excellent Majesty, by and with the advice and consent of the House of Assembly and the Senate of Saint Lucia, and by the authority of the same, as follows:

**Short title**

1. This Act may be cited as the Appropriation Act, 2023/2024.

**Appropriation of \$1,856,719,000 for services of the State of Saint Lucia for the year 2023/2024**

2. There shall be and there is hereby granted to His Majesty the King, His Heirs and Successors for the year ending on the thirty-first day of March, two thousand and twenty-four, the sum of one billion, eight hundred and fifty-six million, seven hundred and nineteen thousand dollars, to be paid and appropriated out of the General Revenue and funds of the State of Saint Lucia for the said year in such quarterly amounts as the Minister of Finance considers appropriate and to be approved and to be expended in the manner and for the purposes specified in the Schedule.
