## SAINT LUCIA

STATUTORY INSTRUMENT, 2024, No. 30

[ 11th March, 2024 ]

In exercise of the power conferred under section 109 of the Value Added Tax Act, Cap. 15.42, the Minister responsible for finance makes this Order:

#### Citation

1. This Order may be cited as the Value Added Tax (Amendment of Schedule 3) Order, 2024.

## Amendment of Schedule 3

- **2.** Schedule 3 of the Value Added Tax Act, Cap. 15.42 is amended by inserting immediately after paragraph 28 the following new paragraphs 29, 30 and 31
  - **"29.** The import of lights and lighting infrastructure or equipment by the St. Lucia Football Association.
  - **30.** The import of goods including gym equipment by a sporting organization. In this paragraph
    - "private sector entity" means a registered, incorporated or unincorporated body that is not controlled by the Government:
    - "sporting organization" means a private sector entity involved in sport;
    - "sport" means -
      - (a) aquatics;
      - (b) badminton;
      - (c) basketball;
      - (d) boxing;
      - (e) bridge;
      - (f) chess;
      - (g) combat sports;

## Value Added Tax (Amendment of Schedule 3) Order

- (h) cricket;
- (i) cycling;
- (j) darts;
- (k) football;
- (l) golf;
- (m) hockey;
- (n) horse racing;
- (o) lawn tennis;
- (p) netball;
- (q) rugby;
- (r) sailing;
- (s) softball;
- (t) sports fishing;
- (u) squash;
- (v) swimming;
- (w) table tennis;
- (x) teqball;
- (y) track and field; and
- (z) volleyball.
- **31.** The import of goods by a person who in conjunction with the Government embarks on an undertaking approved by Cabinet.".
