Barrister-at-Law, resident in Pigeon Island, Quarter of Gros Islet in the State of Saint Lucia, of Our especial grace, certain knowledge and mere motion have thought fit to constitute and appoint and by these Presents do constitute and appoint the said RENÉE TAMARA ST. ROSE to be one of Our Counsel for Our States and Colonies to which the jurisdiction of the Eastern Caribbean Supreme Court extends to hold and enjoy within the said States and Colonies all and singular the RIGHTS, ALLOWANCES, PRIVILEGES AND PRE-EMINENCIES to the said appointment belonging or appertaining in as full and ample a manner as any other Our Counsel learned in the Law in any of the said States and Colonies doth hold and enjoy or of right ought to have held or enjoyed the same, and also the liberty of sitting and practising within the Bar of the said Eastern Caribbean Supreme Court in any of the said States and Colonies as any of our Counsel learned in the Law do ought or may.

And We Do Hereby Direct And Enjoin that these Our Letters Patent be published within our Said States and Colonies and be duly recorded in the proper offices therein.

And to the said ends aforesaid, We have caused these Our Letters Patent to be sealed with the Public Seal of Saint Lucia.
