No. 104 of 2025 — Customs Duties (Amendment of Schedule 4) (No. 1) Order.

SAINT LUCIA

STATUTORY INSTRUMENT, 2025, No.104

[1st July, 2025]

In exercise of the power conferred under section 10 of the Customs Duties Act, Cap. 15.04, the Minister responsible for customs makes this Order:

Citation and commencement

1. —(1) This Order may be cited as the Customs Duties (Amendment of Schedule 4) (No. 1) Order, 2025.

(2) This Order comes into force on the 1st day of July, 2025.

Amendment of Schedule 4

2. Schedule 4 of the Customs Duties Act, Cap. 15.04 is amended, in the case of the tariff headings specified in column 1 of the Schedule to this Order, by replacing the description of goods specified in column 2 to this Order and the rate of duty specified in column 3 of the Schedule to this Order.

Expiry

3. This Order expires on the 31st day of May, 2026.
