STATUTORY INSTRUMENT, 2013, No. 23

In exercise of the power conferred under section 19 of the Aliens (Licensing) Act, Cap.15.37, the Minister responsible for finance makes this Order:

Citation

1. This Order may be cited as the Aliens (Licensing) (Exemption)(Drake Intertrade Ltd. and its wholly owned subsidiaries) Order 2013.

Exemption

2. Drake Intertrade Ltd. and its wholly owned subsidiaries are exempted from the provisions of the Aliens (Licensing) Act, Cap.15.37 with respect to the following interests in land, as it is in the public interest to do so:
