1. This Order may be cited as the Consumption Tax (Amendment of Schedule 1) (No. 2) Order 2012.

Amendment of Schedule 1

2. Schedule 1 to the Consumption Tax Act, Cap. 15.03 is amended by substituting the consumption tax rates specified in Column 3 of the Schedule to this Order with respect to the HS Numbers specified in Column 1 of the Schedule to this Order for the description of goods specified in Column 2 of the Schedule to this Order.
