

*Tourism Stimulus and Investment (Pink Papaya-Patio  
Restaurant & Lounge) Order*

## **SAINT LUCIA**

STATUTORY INSTRUMENT, 2016, No. 50

[ 25th April, 2016 ]

In exercise of the powers conferred under section 11 of the Tourism Stimulus and Investment Act, No. 12 of 2014, the Minister responsible for tourism, with the approval of Cabinet, makes this Order:

### **Citation**

1. This Order may be cited as the Tourism Stimulus and Investment (Pink Papaya-Patio Restaurant & Lounge) Order, 2016.

### **Approved development**

2. The furnishing and equipping of Pink Papaya-Patio Restaurant & Lounge located at Pointe Seraphine is declared an approved development.

### **Declared benefit with regard to income tax**

3. The declared benefit with regard to income tax is a one hundred per cent waiver of income tax for a period of three years commencing on the 1<sup>st</sup> day of October, 2015 and terminating on the 30<sup>th</sup> day of September, 2018.

### **Declared benefit with regard to value added tax and customs duty**

4.—(1) Subject to section 5 and subsection (2), the declared benefit with regard to value added tax and customs duty is a one hundred per cent waiver of value added tax and customs duty on —

- (a) furniture, fittings, furnishings, sound and kitchen equipment and appliances, linen, drapery, industrial kitchen equipment imported to furnish and equip Pink Papaya-Patio Restaurant & Lounge; and
- (b) imports of alternative energy and energy saving devices, devices and fittings used for the equipping of Pink Papaya-Patio Restaurant & Lounge.

- (2) The benefits under subsection (1) are —
- (a) applicable for a period of eighteen months commencing on the 1<sup>st</sup> day of October, 2015 and terminating on the 31<sup>st</sup> day of March, 2017; and
  - (b) subject to the approval of Bills of Quantities by the Ministry of Tourism, Heritage and Creative Industries prior to the importation of the items.

**Conditions**

**5.** The benefits declared under sections 3 and 4 are subject to the conditions that —

- (a) the management of Pink Papaya-Patio Restaurant & Lounge submits a bi annual report to the Ministry of Tourism, Heritage and Creative Industries from the date of commencement of the approved development; and
- (b) Pink Papaya-Patio Restaurant & Lounge complies with all other monitory requirements of the Ministry of Tourism, Heritage and Creative Industries and other related Government agencies.
