## **SAINT LUCIA**

STATUTORY INSTRUMENT, 2006, No. 58

[ 12th June, 2006 ]

In exercise of the power conferred by section 26 (1) of the National Development Corporation Act, Cap. 15:24 the Minister responsible for the National Development Corporation with the approval of Cabinet makes the following Order:

### **Citation**

1. This Order may be cited as the National Development Corporation (La Tourney Phase 4 Extension) Vesting Order 2006.

### **Vesting of Land**
