In exercise of the power conferred under section 4 of the Consumption Tax Act, Cap. 15.03 the Minister responsible for Finance makes this Order:

Citation

1. This Order may be cited as the Consumption Tax (Amendment of Schedule 1) (No. 4) Order 2012.

Amendment of Schedule 1

2. Schedule 1 to the Consumption Tax Act, Cap. 15.03 is amended by substituting the consumption tax rates specified in Column 3 of the Schedule to this Order with respect to the HS Numbers specified in Column 1 of the Schedule to this Order for the description of goods specified in Column 2 of the Schedule to this Order.

Commencement

3. This Order is deemed to have come into force on the 9th day of April, 2012 to the 15th day of April, 2012.
