

*Invest Saint Lucia (La Tourney - Vieux-Fort) Vesting Order***SAINT LUCIA**

STATUTORY INSTRUMENT, 2015, No. 13

[ 9th February, 2015 ]

In the exercise of power conferred by section 43 (1) of the Invest Saint Lucia Act, No.14 of 2014, Cabinet makes this Order:

**Citation**

1. This Order may be cited as the Invest Saint Lucia (La Tourney - Vieux-Fort) Vesting Order, 2015.

**Vesting of land**

2. The land described in the First Schedule, Second Schedule, Third Schedule and Fourth Schedule being land owned by Invest Saint Lucia is hereby vested in the Crown.

**FIRST SCHEDULE**

All that piece or parcel of land comprising Block and Parcel Numbers 1218B 158, 159, 160, 161 and 162 situated at La Tourney in the Quarter of Vieux-Fort in the State of Saint Lucia and bounded as follows:
