SAINT LUCIA

STATUTORY INSTRUMENT, 2006, No. 46

[5th June, 2006]

In exercise of the power conferred by section 26 (1) of the National Development Corporation Act, Cap. 15:24 the Minister responsible for the National Development Corporation with the approval of Cabinet makes the following Order:

Citation

1. This Order may be cited as the National Development Corporation (South Augier) Vesting Order 2006.

Vesting of Land

2. The lands described in the Schedules being lands owned by the National Development Corporation are hereby vested in the Southern Development Corporation.

FIRST SCHEDULE

All the pieces or parcels of land being Parcels 163-166 of Block 1020B together with all appurtenances and dependencies thereof situated at South Augier in the Registration Quarter of Vieux Fort and being bound as follows:

North : by the remainder of Parcel 1019B 1083
South : by the remainder of Parcel 1019B 1083
East : by the remainder of Parcel 1019B 1083
West : by the St. Jude /Vieux Fort Highway
