STATUTORY INSTRUMENT, 2020, No. 11

In exercise of the power conferred under section 9 of the Export Saint Lucia Act, Cap. 13.32, the Minister responsible for commerce makes this Order:

### **Citation**

1. This Order may be cited as the Export Saint Lucia (Appointment of the National Export Council) Order, 2020.

### **Appointment of the National Export Council**

2. Subject to section 3, the members appointed to the National Export Council are as follows —

- (a) Marguerite Desir - Chairperson and representative of the Saint Lucia Manufacturers Association;
- (b) Sophia Henry - Deputy Chairperson and Permanent Secretary of the Ministry of Commerce, International Trade, Investment, Enterprise Development and Consumer Affairs;
- (c) Ann-Margaret Adams - Representative of the Ministry of Tourism, Information and Broadcasting, Culture and Creative Industries;
- (d) Auria King-Cenac - Representative of the Department of Agriculture, Fisheries, Natural Resources and Co-operatives;

- (e) Nadia Wells-Hyacinth - Representative of the Department of Finance;

- (h) Nissa Henry who is replaced by Lisa Barton - Representative of the Saint Lucia Industrial and Small Business Association;
- (i) Noorani Azeez - Representative of the Saint Lucia Hotel and Tourism Association;
- (j) Verne Emmanuel - Representative of the Saint Lucia Bureau of Standards; and
- (k) Yvonne Agard - Representative of the Saint Lucia Coalition of Services.

**Term of appointment**

3.—(1) The members of the National Export Council are appointed for a term of three years commencing from the 20<sup>th</sup> day of September, 2019 and terminating on the 19<sup>th</sup> day of September, 2022.

(2) Notwithstanding subsection (1), the replacement member under section (2)(h) as the representative of the Saint Lucia Industrial and Small Business Association is appointed for a period commencing from the 14<sup>th</sup> day of October, 2019 and terminating on the 19<sup>th</sup> day of September, 2022.
