STATUTORY INSTRUMENT, 2003, No. 42

[ 19th May, 2003 ]

In exercise of the powers conferred by section 193 of the Motor Vehicle and Road Traffic Act No. 10 of 2003, the Minister responsible for Transport makes the following regulations:
