

*National Development Corporation (New Dock) Vesting Order***SAINT LUCIA**

STATUTORY INSTRUMENT, 2006, No. 190

[22nd December, 2006]

In exercise of the power conferred by section 26 (1) of the National Development Corporation Act Cap. 15.24, the Minister responsible for the National Development Corporation, with the approval of Cabinet, makes the following Order:

Citation

1. This Order may be cited as the National Development Corporation (New Dock) Vesting Order 2006.

Vesting of land

2. The lands described in the Schedules being lands owned by the National Development Corporation are hereby vested in the Crown.

FIRST SCHEDULE

All that piece or parcel of land being Parcel 1217B 2 together with all appurtenances and dependencies thereof situated at New Dock in the Registration Quarter of Vieux Fort and being bound as follows:

- North** : by an access road
- South** : by an access road
- East** : by an access road
- West** : by an access road

The whole containing 0.05 hectares shown as a Road Reserve on Registry Map Sheet and Block 1217B Parcel 2.

SECOND SCHEDULE

All that piece or parcel of land being Parcel 1217B 99 together with all appurtenances and dependencies thereof situated at New Dock in the Registration Quarter of Vieux Fort and being bound as follows:

- North** : by Parcel 1217B 98 and partly by Parcel 1217B 97
- South** : by Parcel 1217B 126, 127 and partly by Parcels 1217B 4 and 8

East : by a road

West : by Parcel 1217B 5

The whole containing 0.05 hectares shown as 6.9 m access road on Plan of Survey by John Cenac Surveyor dated July 8, 1993 and lodged in the Survey Office on September 10, 1993 as Plan Number VF 1011 R and Record Number 540/93.

THIRD SCHEDULE

All that piece or parcel of land being Parcel 1217B 131 together with all appurtenances and dependencies thereof situated at New Dock in the Registration Quarter of Vieux Fort and being bound as follows:

North : by a vehicular access

South : by a vehicular access

East : by a vehicular access

West : by a vehicular access and partly by 1217B 130

The whole containing 7.98 hectares shown as a playing field on the Registry Map Sheet as Block 1217B Parcel 131.

FOURTH SCHEDULE

All that piece or parcel of land being Parcel 1217B 133 together with all appurtenances and dependencies thereof situated at New Dock in the Registration Quarter of Vieux Fort and being bound as follows:

North : by a drain

South : by Parcel 1217B 132

East : by Parcel 1217B 132, 124

West : by a drain
