

*Immigration (Visa) (Amendment) Order***SAINT LUCIA**

STATUTORY INSTRUMENT, 2007, No. 12

[ 13th March, 2007]

In exercise of the powers conferred pursuant to section 7 (2) and (3) of the Immigration Act, Cap. 76, Revised Laws of Saint Lucia 1957, Cabinet makes this Order:

**Citation**

1. This Order may be cited as the Immigration (Visa) (Amendment) Order 2007.

**Interpretation**

2. In this Order "principal Order" means the Immigration (Visa) Order 2006, S.I. No. 33.

**Amendment of section 3**

3. Section 3 of the principal Order is amended by —

- (a) deleting the words "(2) and (3)" appearing between the words "subsection" and "of" in subsection (1) and by substituting the words "(2), (3) and (4)";
- (b) inserting the following as subsection (4):  
“(4) Where a person referred to in subsection (1) is a citizen or subject of Singapore, the person requires a visa only if the period of stay exceeds fifteen days.”.

**Amendment of section 4**

4. Section 4 of the principal Order is amended by —

- (a) inserting the words "Subject to subsection (3)," before the words "A person" appearing at the beginning of subsection (1); and
- (b) inserting the following new subsection as subsection (3):  
“(3) Where a person referred to in subsection (1) is a citizen or subject of Singapore, the person is exempt from the requirement of a visa only unless the period of stay exceeds fifteen days.”.

5. The First Schedule to the principal Order is amended by —
- (a) deleting the words "ARGENTINA";
  - (b) inserting the following words in their correct alphabetic sequence:  
"BANGLADESH", "CHINA, PEOPLE'S REPUBLIC OF",  
"POLAND" "PORTUGAL" and "UGANDA"
  - (c) deleting the words "GUINEA BISSAHUNGARY ICELAND" where it appears and by replacing them with the following three words each in their correct alphabetical sequence:  
"GUINEA BISSAU", "HUNGARY", and "ICELAND";
  - (d) deleting the words "SAUDIA ARABIA" and replacing them with the words "SAUDI ARABIA";
  - (e) deleting the words "BURKINA FASCO BOTSWANA" and replacing them with the words "BURKINA FASO"; and
  - (f) inserting the words "if the period of stay exceeds fifteen days" in parenthesis after the word "SINGAPORE."

**Amendment of the Second Schedule**

6. The Second Schedule to the principal Order is amended by —
- (a) deleting the words "ARGENTINA", and "NIGERIA";
  - (b) inserting the words "POLAND" and "UGANDA" in the correct alphabetical sequence;
  - (c) deleting the words "GUINEA BISSAHUNGARY ICELAND" where they appear and by replacing them with the following three words each in the correct alphabetical sequence:  
"GUINEA BISSAU", "HUNGARY", and "ICELAND";
  - (d) deleting the words "BURKINA FASCO BOTSWANA" and replacing them with the words "BURKINA FASO".

**Amendment of the Third Schedule**

7. The Third Schedule to the principal Order is amended by —
- (a) inserting the words “BANGLADESH” “CHINA, PEOPLE’S REPUBLIC OF” and “NIGERIA” in the correct alphabetical sequence; and
  - (b) deleting the words “SAUDIA ARABIA” and by replacing them with the words “SAUDI ARABIA”.

**Amendment of the Fourth Schedule**

8. The Fourth Schedule to the principal Order is amended by —
- (a) inserting the words “IRELAND”, “ARGENTINA” and “SINGAPORE (if the stay is less than fifteen days)” in the correct alphabetical sequence; and
  - (b) deleting the words “CHINA, PEOPLE'S REPUBLIC OF”.
