## **SAINT LUCIA**

STATUTORY INSTRUMENT, 2006, No. 61

[ 12th June, 2006 ]

In exercise of the power conferred by section 26 (1) of the National Development Corporation Act, Cap. 15:24 the Minister responsible for the National Development Corporation with the approval of Cabinet makes the following Order:

### **Citation**

1. This Order may be cited as the National Development Corporation (Shanty Town) Vesting Order 2006.

### **Vesting of Land**

2. The lands described in the Schedules being lands owned by the National Development Corporation are hereby vested in the Southern Development Corporation.

### **FIRST SCHEDULE**

All the pieces or parcels of land being Parcels 28-43 of Block 1217B together with all appurtenances and dependencies thereof situated at Shanty Town in the Registration Quarter of Vieux Fort and being bound as follows:

North : by Parcel 1316B 231  
South : by Parcel 1316B 231  
East : by Parcels 1217B 27, 44 and 60  
West : by Parcel 1316B 231

The whole containing 0.32 hectares shown as lot Nos. 11, 12, 14 - 19 and 40 - 47 on Plan of Survey by C.W. Phillips Licensed Land Surveyor dated 11th November 1981 and lodged in the Survey Office on 13th May 1983 as Plan Number VF656 and Record Number 238/82.

### **SECOND SCHEDULE**

All the pieces or parcels of land being Parcels 61-68 of Block 1217B together with all appurtenances and dependencies thereof
