SAINT LUCIA

STATUTORY INSTRUMENT, 2013, No. 30

[13th May, 2013]

In exercise of the power conferred under section 20(4) of the Saint Lucia Air and Sea Ports Authority Act, Cap. 8:13, Cabinet makes this Order:

Citation

1. This Order may be cited as the Saint Lucia Air and Sea Ports Authority (Vigie) Vesting Order, 2013.

Vesting of land

2. Subject to subsection (3), the land described in the First Schedule, Second Schedule, Third Schedule and Fourth Schedule being land owned by the Crown is vested in the Saint Lucia Air and Sea Ports Authority.

Condition

3. The land vested under subsection (2), is subject to the condition that the Saint Lucia Air and Sea Ports Authority makes adequate provision to satisfy the needs of the Marine Unit of the Royal Saint Lucia Police Force of the Ministry of Home Affairs and National Security.

FIRST SCHEDULE

All that piece or parcel of land being Block and Parcel 0849F 38 situated at Vigie in the Registration Quarter of Urban Castries, and being bounded as follows:

- North** : by Block 0849C and Parcel 24
- South** : by Block 0849F and Parcel 41
- East** : by Block 0849F and Parcels 37 and 43
- West** : by Block 0849F and Parcels 39 and 40

The whole containing two point two zero hectares and shown on Map Sheet 0849F.
