SAINT LUCIA

STATUTORY INSTRUMENT, 2006, No. 193

[22nd December, 2006]

In exercise of the power conferred by section 26 (1) of the National Development Corporation Act, Cap.15.24, the Minister responsible for the National Development Corporation, with the approval of Cabinet, makes the following Order:

Citation

1. This Order may be cited as the National Development Corporation (La Tourney Phase 2 Extension) Vesting Order 2006.

Vesting of land

2. The lands described in the Schedules being lands owned by the National Development Corporation are hereby vested in the Southern Development Corporation.
