In exercise of the power conferred by section 8 (2) of the National Development Corporation Act, Cap 5.24 Cabinet makes this Order:

Citation

1. This Order may be cited as the National Development Corporation (Choiseul) (No. 4) Vesting Order 2011.

Vesting of Land

2. The land described in the First Schedule, Second Schedule, Third Schedule, Fourth Schedule, Fifth Schedule, Sixth Schedule, Seventh Schedule and Eighth Schedule being lands owned by the Crown in a special development area, is vested in the National Development Corporation.
