**AN ACT** to amend the Distribution and Price of Goods Act, Cap.  
13.09.

**BE IT ENACTED** by the Queen's Most Excellent Majesty, by  
and with the advice and consent of the House of Assembly and the  
Senate of Saint Lucia, and by the authority of the same, as follows:

No. 17 ] *Distribution and Price of Goods (Amendment) Act* [ 2012.

**Short title and commencement**

**1.** — (1) This Act may be cited as the Distribution and Price of Goods (Amendment) Act 2012.

(2) This Act shall come into force on a date to be fixed by the Minister by Order published in the *Gazette*.
